Business Manager's Message

We hope you and your family are all safe and taking measures to stay healthy. The most important thing right now is to curb the spread of the COVID-19 virus. We need to continue to practice proper hygiene and not risk the health of ourselves and others.

This is why in June, the Union provided personal protective items for our active Local 675 members. Although the items were ordered way in advance we were finally able to receive them for distribution. Each sealed bag contained a cloth mask, KN 95 FDA-approved face masks, disposable face masks, disposable latex gloves, and a 2 oz. hand sanitizer. Thanks to our office staff and business agents working together with our contractors, we were able to make the kits available to our membership.

Local 675 supports all of Hawaii's essential and frontline workers. To assist those affected by the COVID-19 we donated N95 masks to the **Hawaii Foodbank** workers and volunteers for their food distribution efforts. We were also able to assist financially to the **Hawaii Foodbank** via the Hawaii Building & Construction Trades Council and the Hawaii State AFL-CIO. The demand for donated food is extremely high right now and the **Hawaii Foodbank** is there to help those in need in our community including our own union workers.

By order from the City and State as well as recommendation from the United Association, the general membership meetings and island rap sessions for the months of April and May were cancelled. As soon as we move through the summer months we anticipate starting up the monthly meetings again beginning in

September. Also a notation that the annual Labor Unity Picnic held at the Waikiki Shell every Labor Day weekend is unfortunately cancelled this year due to the COVID-19.

Even during this time of unprecedented government-mandated shutdowns, as essential workers we recognize that we need to continue moving our industry forward. We were able to organize three companies to date. **APB Construction Group** in January, **Tabla Mechanical** in April and **Industrial Fire Sprinklers** in May of this year.

As you may also be aware from current events, the funds financially have not escaped the effects of the COVID-19 pandemic. The resulting fear of the widespread virus caused the U.S. stock market to have the worst drop in March since the 2008 recession. In the course of the coronavirus outbreak, our Pension Fund dipped into an all-time low, as expected. Last year the ratified permanent diversion of the Union's \$.50 per hour work dues towards the Pension Fund along with other changes was made so we could keep the \$100 benefit unit for the members. The funds were doing well prior to the pandemic which helped lessen the full impact of the market crash. For diversification purposes, our contractors, as negotiated beginning 2021, will be contributing \$.50 per work hour towards the Annuity Fund for our members' secured income account. Financially, the Health & Welfare, Training, Annuity and Cooperation funds were also impacted but are now on a steady course. The Trustees, both Union and Management will review and make important decisions before the fiscal year-end date of July 31, 2020.

There is hope for all of us together in the same boat. Recently, the experts have noted that there may finally

UA Notice Regarding Monthly Dues for Unemployed Members

Securing relief for UA members and their families who have been impacted by the COVID-19 is among the greatest priorities at the International level. While the job losses arising from **COVID-19** are still a relatively recent occurrence, many of our brothers and sisters nation-wide are already feeling the financial effects and virtually all members are looking to the future with at least some sense of uncertainty. Because of this, the UA has sent notice to all local unions regarding the monthly dues payment.

For the months of April and May 2020, and thereafter on a month to month basis at the direction and discretion of UA General President Mark McManus and General Secretary Treasurer Patrick Kellett, Local Unions shall cover the fixed monthly dues (\$31.00) of all non retired members who performed 40 or fewer hours of UA work in the previous calendar month. For example, if a member performed only 32 hours of UA work in March, his or her monthly dues for April shall be covered by the Local Union. Non-retired members who qualify for the relief will be credited for the eligible months.

Protecting Worker Health Related to Coronavirus (COVID-19) United Association (UA) and CDC Recommendations

The Centers for Disease Control and Prevention (CDC) recommends that workers perform the following preventive/protective actions, generally and while at work:

Wash hands frequently with soap and water for at least 20 seconds immediately after working on a sanitary waste and vent system.

Avoid touching face, mouth, eyes, nose, or open sores and cuts while working on a sanitary waste and vent system.

- After working on a sanitary waste and vent system, wash hands with soap and water for at least 20 seconds before eating or drinking.
- After working on a sanitary waste and vent system, wash your hands with soap and water for at least 20 seconds before and after using the toilet.
- Before eating, remove soiled work clothes and eat in designated areas away from human waste and sewage-handling activities.
- Do NOT smoke or chew tobacco or gum while working on a sanitary waste and vent system.
- Keep open sores, cuts, and wounds covered with clean, dry bandages.
- Gently flush eyes with safe water if human waste or sewage contacts eyes.
- Use waterproof gloves to prevent cuts and contact with human waste or sewage.
- Wear rubber boots.
- Remove rubber boots and work clothes before leaving worksite.
- Clean contaminated work clothing daily with 0.05% chlorine solution (1-part household bleach to 100 parts water).
- Clean and disinfect tools and equipment used.
- Clean and disinfect the work area frequently.
- Cover your cough and/or sneeze with your bent elbow.
- Do not report to work when you feel ill.
- Report and document all exposures.
- If you start to feel ill, inform your supervisor immediately and document the
- Currently there is not a vaccination for COVID-19 but it is recommended that all other vaccinations be current.

Practice Social Distancing

Finally, it is important to follow social distancing recommendations. Try to keep a minimum six-foot distance between others. Remember, it could take anywhere from 2 to 14 days for COVID-19 symptoms to appear, if they even appear at all. If you believe you have contracted the virus, stay home, contact your supervisor and seek assistance from your medical provider.

Hawaii Votes By Mail

2020 ELECTION DATES & DEADLINES

Election Day

Primary: August 8, 2020 General: November 3, 2020 Voting closes at 7:00 p.m.

Voter Registration Deadline

Primary: July 9, 2020 General: October 5, 2020

Absentee Ballot Request

Primary: August 1, 2020 General: October 27, 2020

Voter Service Centers

Primary: July 27, 2020 through Election Day, August 8, 2020 General: October 20, 2020 through Election Day, November 3, 2020 (Excluding Sundays)

The State of Hawaii passed **Act 136, SLH 2019**, implementing elections by mail beginning with the 2020 Elections. The 2020 Primary Election will be the first statewide election conducted by mail and no traditional polling places will be opened. Instead, all voters will automatically receive a ballot in the mail.

Keep Your Voter Registration Record Up to Date: Ballots are mailed to the voter's mailing address associated with their voter registration record. Voters who have moved, changed their name or mailing address, must update their voter registration. Voters may check online or call their Clerk's Office to confirm that their voter registration is current. If you do not receive a signature capture card in the mail, check your voter registration online at olvr.hawaii.gov or by contacting the Office of Elections. For more information about elections by mail, contact the Office of Elections at (808) 453-VOTE (8683) or elections@hawaii.gov.

Not yet registered? Register online at www.elections.hawaii.gov or complete a Voter Registration Application and submit it to your Clerk's Office.

Receiving Your Ballot: All properly registered voters will receive a mail ballot packet approximately 18 days prior to the election. (ON OR AFTER JULY 21, 2020)

Returning Your Ballot: Voters may return their ballot by mail or in-person at a designated place of deposit. Voted ballots must be received by the Clerk's Office by 7:00 p.m. on Election Day.

- **By mail:** Voters should mail their voted ballot **2-3 days before the election** to ensure that the Clerk's Office receives it by the deadline. The return envelope is postage paid via the U.S. Postal Service and addressed to your Clerk's Office.
- **Voter Service Center:** Voters may visit any voter service center within their county to drop off their voted ballot.
 - Clerk's Office: Voters may return their voted ballot directly to their Clerk's Office.

SIGN, SEALED, AND COUNTED - SECURING YOUR VOTE

Processing Your Ballot: Upon receipt of your return envelope, the Clerk's Office conducts a signature validation. After your signature is validated your ballot will be forwarded to State Election Officials to be counted. (You should have received an election mailing in April asking for a current sample of your signature.) If there is no signature on the return envelope or it does not match your record, the County Elections Division will notify you and you will have up to 5 business days after the election to correct it in order for your ballot to be counted.

Voter Service Centers: The Clerk's Office establish voter service centers that will be open 10 days prior to each election. Voters may visit any service center within their county should they prefer to vote in person. Additionally, the service center will provide accessible voting and same day registration. See **elections. hawaii.gov** for voter service centers locations.

Training News

Due to COVID-19, the Apprenticeship Graduation ceremony was cancelled for the Fall 2019 - Spring 2020 graduates. Head Training Coordinator **Chuck Shima** stated, "Graduates from this class will have the opportunity to attend the Fall 2020 - Spring 2021 graduation ceremony." He also noted that the 2020 Instructor Training Program (ITP) held every summer in Ann Arbor, Michigan was cancelled.

The Training Office was tasked, with approval from the JATC, to place all apprentices statewide on home study courses. This was to help the apprentices complete the Spring 2020 semester-related classes.



The training coordinators, **Kirk Kageno, Ronden Numasaki,** and **Chuck Shima** have been using video communication conducting Zoom online classes as well as utilizing blackboard online classes. In addition, they have been busy correcting the lessons as well.

In June, the community colleges across the state have been allowing in-person classes provided health and safety guidelines of the college are practiced. Training will complete hands-on training for the 5th year apprentices who will soon become journeymen.
